## 2025 TEXAS DISTRICT - AREA A SLATE WITH POSITION DESCRIPTIONS

*\*Names marked with asterisk are incumbents eligible for re-election.*

### District Secretary

**District Secretary:** (max. of 4 successive - 3yr. terms)

The District Secretary shall:

- Perform the usual duties outlined in the Handbook of the Synod, which includes the following:
  - Receives nominations for district president, area vice presidents and results of circuit visitor selections for the district convention
  - Certifies voting and nonvoting advisory delegates for synod and district conventions.
- Keep an accurate list of congregations by circuit and shall make this list available upon request;
- Function as directed by the district president in agreement with resolutions passed by the district convention;
- In conjunction with the district president, keep the district handbook up to date;
- Serve as secretary of the board of directors; and
- Vote as a member of the board of directors.
- Meets six times annually with the Board of Directors.

### District Board of Directors

**District Board of Directors** (max. of 2 successive - 6yr. terms)

- Consists of the District President, four Vice-Presidents, and Secretary; five Laypersons (one from each administrative area of the District and one "at-large") and two Commissioned Ministers . . . .
- It is suggested, but not required, that one Layperson be an attorney.
- Serves as the coordinating body of the District.
- Implements Convention resolutions.
- Acts in behalf of the District between conventions.
- Has the responsibility of filling all vacancies on District Boards and Committees, etc., between conventions, and electing the Executive Personnel of the District, e.g., BMA and BCE.
- Reviews actions taken by District Boards and Committees.
- Determines the annual budget and manages the fiscal affairs of the District.
- Meets six times annually.
- In general, members of the Board of Directors ought to have a theological, ecclesiastical, and fiscal acumen to administer the affairs of the District.

## Board for Mission Administration

### **The Board of Mission Administration (*max. of 2 successive - 6yr. terms*)**

- Consists of eleven members: five Ordained Ministers, one Commissioned Minister, and five Laypersons
- Develop the overall strategy for new church planting in the Texas District
- Keep itself informed on all mission developments and opportunities within the District
- Investigate and utilize new and established techniques and procedures which will expedite its work and
- Help to realize the mission potential of the District
- Regard the mission performance of financially supported congregations in the District as its responsibility, toward which help, encouragement, and guidance are to be directed
- Provide appropriate financial assistance to fields and congregations for expansion, extension, or intensification of the mission program
- Give special attention to congregations and communities which are either changing or declining in population and seek opportunity to confer with such congregations
- Give attention to the need for new approaches and forms of ministry to meet special needs;
- Recommend personnel changes as needed to fulfill its responsibilities;
- Solicit the assistance of congregations, auxiliary organizations, and individuals for specific mission projects and the total mission program of the District;
- Disburse student aid funds in conformity with the rules and regulations of the District;
- Encourage the formation of local networks in the District to begin new work and enhance present ministries and to work with such local networks to meet the mission challenges of the District; and
- Have the authority and responsibility to call or contract for suitable personnel for all areas of its work where there is no organized congregation, such as:
  - New mission fields
  - Special ministries
- Needs people who are knowledgeable about finances, investments, real estate, and population patterns
- Actual days for BMA involvement include:
  1. A Friday and Saturday in Austin each January
  2. An occasional 2-3 day conference in the Spring
  3. A 2-3 day retreat in early August.

## District Nominating Committee

### **District Nominating Committee (*max. of 4 successive - 3yr. terms*)**

- Solicits recommendations for nominations from congregations, pastors, and circuit visitors of the District
- Obtains the consent of potential nominees
- Publishes the nomination materials in the Convention Workbook (District Handbook 9.005d)
- Presents a slate at the District Convention for offices other than President and Vice-Presidents, with pertinent information on each nominee (District Handbook 9.005d).
- Needs to have a general knowledge of the congregations, laypersons, pastors, and commissioned ministers of all the regions of the District.

### **Synod Nominating Committee (Ad Hoc)**

*In preparation for the 2026 convention of the Synod, the Texas District shall elect, through its regular election procedures at the district convention, shall elect one professional church worker to serve on the Committee for Convention Nominations and one alternate.*

#### **2026 Synod Committee for Convention Nominations**

The Committee for Convention Nominations is to be regarded as an *ad hoc* convention committee, to which limitations on holding multiple offices do not apply.

The Committee for Convention Nominations shall select candidates for all elective offices, boards, and commissions except President, First Vice-President, and vice-president positions requiring regional nominations (Bylaws 3.12.2.7–8).

Persons elected to this committee must be prepared to serve at the call of the Secretary of the Synod at least six (6) months prior to the next Synod convention and to participate in two (2) or more meetings in St. Louis in the months immediately following.

The committee will base its decisions upon review of biographical and evaluative information regarding candidates whose names were submitted by persons from throughout the Synod. Members of the committee should be able to work closely with other committee members for the common good of the Synod and be willing to set aside personal interests as appropriate in order to place into nomination those candidates most qualified to carry out the responsibilities of the offices being filled.

Members of the Committee for Convention Nominations may also be asked to serve at the time of the Synod convention to process nominations from the floor.
